

Workshop on advocacy and promotion of children's rights around the globe
conducted by FMSI
Rome/Geneva, 21 May - 2 June 2012

OVERVIEW

Marist International Solidarity Foundation (FMSI), Geneva, has developed a ten-day child rights training workshop. The intended participants are key personnel from the Marist Brothers' Provinces¹ around the world. These people, called 'link persons', have a significant role in promoting the rights of children through advocacy efforts and conducting workshops within their own region. This workshop is intended to introduce them to the mechanisms of the United Nations, especially treaty monitoring bodies and the Universal Periodic Review and how to use these mechanisms to promote the rights of children and defend their rights in their own countries. The skills learnt in this workshop will equip the participants with the skills to conduct similar workshops in their region, as well as promote a *rights-based approach* for province organizations who work with children.

The program will embrace lectures, visits to the UN for some UPR sessions, listen to guest speakers from permanent missions, UN agencies and other NGOs on how to engage in advocacy and establish support networks in this field of work. They will develop a *Personal Action Plan* for advocacy and child protection and equip them to lead child rights advocacy and training in their own province.

The facilitators of the program will be:

The participants arrive on Sunday 20th May. The course finishes at lunchtime on Saturday 2nd June.

Program learning Objectives:

The program will facilitate participants in

- Gaining a knowledge and understanding of children's rights as defined in the Convention on the Rights of the Child (1989);

- Understanding and using the various human rights (especially children’s rights) monitoring systems of the United Nations for promoting and defending the rights of children;
- Learning how to collect data for reporting to the Universal Periodic Review (UPR) and treaty monitoring bodies of the UN and how to follow up recommendations made by these UN instruments for promoting children’s rights locally and nationally;
- Understanding how a rights-based and child focused approach to working with children can lead to better and more sustained outcomes for children;
- Understanding and implementing a rights-based approach for their own organization’s work with children;
- Enhancing participants’ competence in developing and accessing networks to monitor local and national implementation of the Convention on the Rights of the Child;
- Understanding & applying best practice in the promotion and protection of children’s rights.

METHODOLOGY

This workshop will value the participants experience as a resource for learning. As far as possible the methodology will integrate theory, knowledge content, best practices, sharing of experiences, and experiential forms of learning, drafting reports and data collection. It will integrate the learning through lectures, guest speakers, film clips and attending UN session on human rights (UPR).

Activities:

Journaling: each participant is encouraged to maintain a reflective journal throughout the program.

Reading: Selected readings will be assigned at different points for reflection, study and discussion.

Working groups: Groups of 4 or 5 participants engaging in concrete learning tasks.

Discussion Groups: larger groups of 7 or 8 participants engaged in focussed activities, including panel interviews and role plays.

Developing a personal Action Plan that will guide their work when they return home.

LANGUAGES OF THE COURSE: **English and Spanish**

The course will be offered simultaneously in both **English** and **Spanish**. Professional translators will be engaged for these simultaneous translations and translation audio headsets will be provided for the participants.
